Al Governance: Board Approval Briefing

Purpose

Use this sheet to help safeguard tenants, uphold your values, and avoid reputational or regulatory risk when approving any AI-related activity. It's your quick scan for responsible, transparent, and tenant-centred decision-making.

5 Key Questions to Ask Before You Approve

- Is it clear how this AI tool makes decisions? Can staff explain it to tenants?
- Who owns it internally? Has a named exec and operational lead been assigned?
- Have tenant rights been considered? Was a DPIA done? Are decisions fair and GDPR compliant?
- Is there independent oversight? Has this been reviewed by a cross-functional group or ethics panel?
- Are we locked in or can we walk away? Does the contract include audit rights, bias checks and exit terms?

Green / Amber / Red Flags

Status	Signal
	DPIA completed, explainability built-in, AUP in
	place, tenants informed
	Still piloting, governance work underway,
	vendor open to questions
	No privacy or bias checks, no clear owner,
	vendor won't share model info

Board Assurance Checklist

- Acceptable Use Policy in place
- DPIA completed (if tenant data involved)
- Bias and fairness checks run (esp. for allocation or arrears tools)
- Procurement includes transparency, audit & liability clauses
- Tenants informed & able to question decisions
- Plans for review, monitoring and escalation logged

L If in Doubt, Pause and Escalate

- · You don't know who owns it internally
- It affects tenant outcomes, but no DPIA or bias check has been done
- It's a third-party tool with no procurement checklist or contract scrutiny
- Staff or tenants have raised concerns with no formal response

Bottom Line: All can help — but only if it's governed. This cheat sheet gives you confidence to say yes for the right reasons, and to say "not yet" when needed.
