

DASH Vendor Questionnaire Template (Digital & Al Suppliers)

1. Introduction

This questionnaire helps housing providers evaluate digital and AI suppliers against best practice in governance, security, and compliance.

It has been developed using:

- Responsible Al Institute (RAI) Supplier Assessment Framework
- Risk Management Framework for AI Procurement (aligned with NIST AI RMF & ISO 42001)
- Al Policy Template (RAI) for clear governance guardrails
- Public Sector Best Practice UK Gov Procurement Policy Notes on AI, GovAI Coalition templates, and international procurement toolkits

The questionnaire balances:

- Mandatory standards (security, GDPR, regulation)
- Quality measures (fairness, sustainability, support)
- A traffic-light dashboard for leadership assurance

This questionnaire is designed to help housing providers evaluate digital and Al suppliers quickly and consistently. Mandatory elements must be passed to proceed. Evidence should be provided for all responses.

2. Scoring System

Each question should be scored as follows:

- 0 = No evidence / not compliant
- 1 = Partial evidence / developing
- 2 = Strong evidence / fully compliant

Overall assessment:

- Green: ≥80% - Amber: 60–79%

- Red: <60% OR any mandatory fail
